2. Relation between the field of study and the university mission and its strategy of development

The field of the *English Studies* aligns with the mission of the University of Zielona Góra which focuses on "rebalancing chances of the region and development opportunities of its inhabitants, on reinforcing the intellectual, economic and artistic potential by educating staff at the highest level and by conducting high quality academic research. The aim of the university is to prepare the qualified staff that is necessary in the region and in Poland". English, the contemporary lingua franca, is the language used by 1.4 billion people all around the world. It is the official language of the majority of global organizations, the language of the Internet, business, finance, economy and tourism, which makes it the most desirable by employers. In order to meet these expectations, the education programme of English Studies is designed to face the demands of the labour market with the emphasis on expanding knowledge about the English speaking countries, on developing critical thinking, on acquiring interpersonal skills and on becoming more sensitive to cultural diversity. It is also important to make students realize the necessity of the life-long learning, as indicated by the European Union and superior for the Erasmus+ exchange programme attended by many students of English Studies. These activities improve competitiveness in the labour market

and prepare students to function effectively in the globalised society. An important task of English Studies is to ensure their students extensive education. It refers to teachers of English who are ready to perform their job at all school and extra-school levels, and potential employees equipped with relevant knowledge and cultural competence to start their activity at the business market.

3. Competence expected from candidates applying for MA English Studies

Form of studies:

two-year intramural and extramural education leading to the academic degree of MA (Polish: magister)

Candidates are accepted according to the sequence in the ranking list prepared on the basis of credits in the following way:

- 1. Number of credits resulting from the graduation grade in the diploma,
- 2. Compliance or relation of studies graduation field with the chosen field of MA studies, related fields are all philological fields.

Recruitment is carried out compliant with the rules to establish credits for MA studies included in the general regulations.

4. Compliance analysis of the assumed effects of learning with the needs of the labour market

The assumed effects of learning which emphasise the active command of English in theory and practice, advanced level of the cognitive processes, interpersonal competence, openness to different languages and culture, and knowledge about culture, history and social and political conditions typical of the English speaking countries help graduates to face their work challenges and meet the employers' expectations. Employers search for employees with good command of foreign languages, particularly of English. Language competence allow graduates to get employed in various business sectors as they refer to the whole labour market. Graduates with the proficient command of English and knowledge about the political system, traditions and culture of the English speaking countries can find employment in the following areas:

- (1) school and out-of-school education,
- (2) cultural institutions,
- (3) mass media,
- (4) translation offices,

(5) state and private business companies cooperating with the English speaking partners, institutions and associations applying for funds and grants, etc.

Graduate profile

Graduates of MA English Studies are well-acquainted with literature, culture, tradition and history of the English speaking countries and are well educated linguistically. Graduates are specialists of the English language at the level close to C2 of the Common European Framework of Reference for Languages: Learning, Teaching, Assessment. Graduates equipped with such knowledge and skills are prepared to gain additional qualifications that enable them to work as translators, editors, and propagators of the English culture. They can find employment in the cultural institutions, publishing houses, editorial offices, radio and TV, administration and in companies and business entities which cooperate with the English speaking countries such as transportation and logistics.

As students of MA English Studies continue learning the second foreign language, graduates can use it at B2+ level, which is an extra asset in the labour market.

Teaching specialisation

Students of the teaching specialisation continue their studies initiated at BA level. Graduates are granted the master's degree (Polish: magister) and are qualified to work as teachers of English from the 4th to the 8th grade of the primary and secondary school according to the Regulation of the Ministry of Science and Higher Education concerning standard of education preparing students to work as a teacher (Journal of Law item 1450 with later amendments). Students are admitted to study the teacher's specialisation only if they completed BA English Studies. Candidates who graduated from other university than University of Zielona Góra are obliged to complete the differences in university curriculum resulting from a versatile approach to meet the educational standard for teachers in different universities.

Translation specialisation

Graduates of the translation specialisation are equipped with knowledge and skills in the scope of translation theory and practice. They are well-prepared to translate both literary and specialized texts and interpret speeches from Polish into English and vice versa. They are knowledgeable about peculiarities of the translator's profession including the profession of the certified translator. They are prepared to write a state exam to become a certified translator. Additionally, they are acquainted with and know how to use basic techniques of audiovisual translation.

5. Description of ways to verify and to assess the effects of learning students achieve throughout the process of education

General policy for granting students credits at the end of the semester is included in the Regulations of Studies at University of Zielona Góra passed by the UZ Senate with the Resolution No. 478 as at 27th April 2022.

The regulations of verifying and assessing a degree of achieving the effects of learning binding for the English Studies are described in the syllabi designed for each subject. Teachers inform their students about criteria according to which they will be assessed during their first classes. Verification and assessment take place on an ongoing basis. Grades are public and students have the right to see how their work has been assessed. Teachers collect the documentation that serves to verify the progress in the effects of learning and they certify a degree of achieving the effects by students. When verifying the effects of learning an assumption is made that students get a positive grade from an exam or a credit at the end of the semester, a positive grade from the diploma paper and diploma exam, and a positive grade from the professional practice if all effects of learning established for a given educational process have been achieved. A degree to which the given effects of learning have been achieved results from the granted grade.

The methods of verifying and assessing the effects of learning are extensive and include the specific character of the effects (knowledge, skills, social competence). Methods of verifying the effects in reference to knowledge are quizzes, tests (open and closed questions), verbal tests, presentations. Assessment of the achieved effects of learning in reference to skills is made based on observing students during classes, auditing students verbal and written assignments. Social competence are verified on the basis of observing students during their individual and team work in classes, seminars and projects. Language skills are verified on the basis of the students' speaking tests, written assignments (description, quiz, test). The methods applied to verify and assess students are described in the register of subjects that is available on the university website and presented to students at their first classes. At the end of the educational process the MA exam is conducted. The exam is verbal. Students present their theses and research findings and answer questions related to their diploma paper and the relevant field of studies.

Exams can be verbal or written. The written exam includes multiple choice closed questions, tests with open questions, written assignments with open questions. Exam topics refer to the educational content described in the syllabi designed for the subject the exam relates to. In the syllabi conditions and criteria that are necessary to grant students a positive grade and the final credit are described. When it comes to the verbal exam students select a set of questions prepared by teachers and prepare to answer them, and after preparation they answer them verbally. The exam result (positive or negative) is announced to students right after the exam. If students disagree with the exam grade, they have the right to refer to the dean in line with the Regulations of Studies binding at the university.

Effects of learning regarding knowledge and research skills are also assessed when students prepare their MA paper and in the course of MA exam which is held at the end of the studies. Exam is verbal and in English. MA exam tests students' ability to conduct independent research, in particular an ability to answer questions, to justify arguments in reference to their research (interpretation of the findings, selection of the methodology, etc.) and an ability to critically analyse and synthesise the selected notions of the relevant discipline. Students present theses and their findings, and answer three questions in the scope of the relevant academic discipline. At least one question concerns the context of the diploma paper. The exam tests if students achieved the assumed effects of learning.

Programme of studies enables students to choose classes to which ECTS credits are assigned in less than 30% of ECTS credits.

7. Vocational practice policy

Practice in the field of *English Studies* refers to students who chose the teaching specialisation. It is conducted only as a consequence of the 60h teaching practice that was completed at the BA studies. The MA programme of studies includes the practice of the teaching specialisation in the scope of 60h teaching practice (in total the BA and MA studies include 30h of the pedagogical practice and 120h of the teaching practice according to the teachers' education standard specified in separate regulations).

In the Faculty of Humanities there are coordinators of students' practice who provide students with help and information on practice.

The purpose of the teaching practice is to give students an opportunity to gain experience related to the teachers' psychological and teaching work and to confront the acquired teaching knowledge (the methodology of teaching) with the pedagogical reality.

Practice takes place in schools where teachers are required to have qualifications specified in regulations issued on the basis of Article 9, item 2 of act as at 26^{th} January 1982 – The Teacher's Charter.

Students are obliged to get a permission from the school headmaster, teacher or practice coordinator in order to begin the practice. Several students can complete the practice with the same teacher only if the teacher holds a sufficient number of hours necessary to complete the practice. The date when students begin their practice in a given school is specified by the practice coordinator. It is recommended that practice takes place on a regular basis throughout the whole semester. Consolidating or shortening the practice is unacceptable. Students are obliged to be ready to begin the practice from the first day and on the first day they should come to school with full documentation and practice instruction.

The practice is completed if students get a positive grade from the practice and if they submit the practice documentation on time. The final grade is granted by the practice coordinator on the basis of the documentation specified in the Practice Regulations and information gained from school teachers and students' portfolio. As an exception the date of submitting the practice documentation can be postponed only if students submit a written request to the dean and get the dean's permission. If students did not complete the practice within the specified term due to the justified reasons such as participation in the students' exchange, ill-fated reasons, the dean can grant a permission to complete the practice within a different term.
